Bidders shall have to give declaration regarding distribution of quantity in **six months period i.e. from April'17-September'17** within 7 days of auction. In case of non-submission of the same, bid quantity will be distributed in equated monthly installments for six months period. However, distribution of lifting program can be recast, if needed based on mutual consent of buyer and seller.
