All Power Producers (excluding CPPs), desirous of procuring coal from the mines of BCCL for own consumption, are hereby informed that **Special Forward e-Auction for Power Producers 2020-21 Phase-III by Rail mode is scheduled to be held on 03.07.2020 through M/s M Junction Limited.** Schedule of dates of the said auction is as under:

The **Special Forward e-Auction for Power Producers 2020-21 Phase- III** will be conducted as per the terms and conditions mentioned in the scheme of Special Forward e-Auction for Power Producers with all modified modalities circulated by CIL over time. In addition to the above, the modified modalities for **Special Forward e-Auction for Power Producers-2020-21 Phase- III** will be as follows:-

- Special Forward e-Auction for Power Producers 2020-21 Phase-III** will be conducted for the period July-September 2020.
- The following discounts on Notified Price of coal will be applicable on booking and subsequent loading of the rakes by the successful bidders in this auction:

No. of Rakes	Discount percentage on notified price
Up to 50	Nil
51 to 75	1%
76 to 100	2%
101 to 125	3%
126 to 150	4%
151 to 175	5%
176 to 200	6%
201 to 225	7%
226 to 250	8%
251 to 275	9%
276 and above	10%

- The discount will be applicable on loading of rakes as per above slabs. For example, if a successful bidder books 140 rakes, he will be eligible for discount of 4%. But, if the actual loading of rake falls below the booked quantity of 140 rakes and load only 120 rakes, then the discount will be applicable at the rate of 3% for the 120 rakes and excess discount availed, if any, will be adjusted.
- The successful bidder who **fails to load minimum of 51 rakes** will not be eligible for any discount.
- The EMD amount will be accepted from the consumers in the form of BG only.** The EMD in the form of BG will be 20% of applicable reserve price of coal.
- The validity of the BG shall be at least throughout the pendency of lifting plus 90 days.
- The schedule for deposition of coal value **by Rail Mode** will be as per the scheme of Special Forward e-auction for Power Producers.
- Applicable price on the date of despatch of coal would be variable in line with the changes in the notified price of CIL/BCCL, i.e. the percentage increase over the reserve price at which the bid is clinched, shall be applicable over the revised reserve price arising out of price revision, if any, on the date of dispatch. However, any changes in the methodology/guiding principle for determining the reserve price in subsequent days would not be applicable for revision of current method of determining the reserve price, except for change in the notified price as mentioned above.
