All Power Producers (excluding CPPs), desirous of procuring coal from the mines of BCCL for own consumption, are hereby informed that **Special Forward e-Auction for Power Producers 2019-19, Phase-V** by Road mode is scheduled to be held on **14.02.2019 through M/s M. The **Special Forward e-Auction for Power Producers 2019-19 Phase-V** will be conducted as per the terms and conditions mentioned in the scheme of Special Forward e-Auction for Power Producers. In line with the above, the modified modalities for Special Forward e-Auction for Power Producers-2019-19-Phase-V will be as follows:-

- Bidders shall have to give declaration regarding distribution of quantity in **two months period i.e. for Feb '19 & March '19** within **7 (seven) days** of auction. In case of non-submission of the same, bid quantity will be distributed in equated monthly installments for the period. However, distribution of lifting program can be recast, if needed based on mutual consent of buyer and seller.
- Bid price will be expressed in terms of percentage premium over Notified Price on the date of bidding. Percentage premium will remain constant throughout the lifting period of the e-Auction.
- Bid Price will be subject to revision with the changes in Notified Price of coal if any. Revised Bid Price will be calculated by adding percentage premium over the revised Notified Price prevailing on the date of supply.
- Change in Bid Price will only be upward in nature i.e. only upward Notified Price revision will be considered. In case of downward revision in Notified Price, the bid price at the date of bidding will prevail at the time of supply.
