In case of failure of the buyer to renew the bank guarantee before 15 days from the date of expiry of the BG, NLCIL shall have the right to encash the Bank Guarantee. In case this levy is not collected by the State Govt. of Odisha then the BG for additional Levy shall be returned based on the decision by the State Govt. of Odisha in this regard. Further if the State Govt. of Odisha decides to collect the additional Levy then the buyer shall be asked to pay the same to NLCIL and if the buyer fails to make the payment the same shall be recovered from the BG GST @ 5%, GST Compensation Cess will be levied @ Rs.400/- per Tonne.</b> <b>Income Tax: 1 % on total Sale Value without Form 27 'C'. ✓</b> (With Form 27 'C' = Nil)</p>
